## Abstract

The Temple Archive documents three centuries of the extended Temple family and local Framingham history. Over 30 members of the Temple family are represented in this collection, but the two family members who are most documented in these materials are Josiah H. Temple (1815-1893) and John H. Temple (1853-1936). While much of this archive is dedicated to documenting the lives and work of the Temples, it also includes 18<sup>th</sup> and 19<sup>th</sup> century Framingham documents that have no clear relation to the Temple Family.

## Provenance

Bequest of Blanche Partridge

These materials were collected by generations of Temples, most notably: Josiah H. Temple (1815-1893), John H. Temple (1853-1936), and Blanche Partridge (1891-1981). This provenance informs which line of the Temple family is most represented in these papers, with the majority of the material related to the direct lineage and descendency of Josiah H. Temple.

The 18<sup>th</sup> and 19<sup>th</sup> century Framingham documents that have no clear relation to the Temple Family were likely collected by these Temple family members as they researched local history in the late 19<sup>th</sup> and early 20<sup>th</sup> century.

The bulk of these items were donated to the Framingham Historical Society (now the Framingham History Center) sometime shortly after Blanche Partridge's death in 1981.

If not otherwise specified, the items in this finding aid are part of the Temple Family Archive under Object ID 2010.7.1 (bequest of Blanche Partridge)

## Historical Context

According to Josiah H. Temple's *History of Framingham*, the Temple family of Framingham is descended from Robert Temple, an English settler in Saco, Maine who died in King Philip's War. Robert's son, Richard (1665-1737), who settled on the land that would become Framingham in 1697. Richard served as an early selectman of the newly incorporated Town of Framingham. The Temples have been long associated with "The Temple Place," a family farm established in the Salem End neighborhood of Framingham by Richard's son, Thomas. The Temples remained for many generations in Salem End, and Temple Street, in that part of Framingham, was named for them.

From Richard's settlement in 1697 through the late 20<sup>th</sup> century, the Temple family remained prominent in Framingham politics and culture, and produced a number of family members who collected and documented both family and local history. These members include Josiah H. Temple (1815-1893) – reverend, historian, and author of *A History of Framingham, Massachusetts*; John H. Temple (1853-1936) – Josiah's son, lawyer, historian, and President of the Framingham Historical Society; and Blanche Partridge (1891-1981) – Josiah's granddaughter, John's secretary, and clerk of the Framingham Historical Society for twenty-eight years.

## Series 2: Josiah H. Temple (1815-1893)

Josiah H. Temple was a historian, reverend, and politician born and raised in Framingham, Massachusetts. Though he lived much of his life in Framingham, he spent some years in Hartford, Connecticut, where he ran a publishing business (J.H. Temple & Co.), and in Whately, Massachusetts, the site of his first ministry after attending Seminary. Temple served briefly in the MA House of Representatives He authored many local history books including *An Ecclesiastical History of Whately* and *A History of Framingham, Massachusetts*.

This series includes Josiah H. Temple's correspondence, diaries, original research and compositions, and other various personal papers. The papers of Josiah's wife, Mary Belden Temple, can be found in Series 4.

## Series 3: John H. Temple (1853-1936)

This series contains papers relating to John H. Temple, son of Josiah H. Temple and Mary Belden Temple. Temple was a deacon, writer, historian, lawyer, and president of the Framingham Union Hospital. He was a prominent member of the Framingham community, serving as president of the Framingham Historical and Natural History Society from 1907-1908 and continual supporter of the Society until his death in 1936.

The papers in this series include Temple's correspondence, notebooks and diaries, original research and compositions, business and legal papers, materials relating to the administration of estates (most notably local poet Edna Dean Proctor), and correspondence with/papers of John's wife, Ella Parsons Temple.
